PDC EXECOM RESOLUTION NO. 09-2006

A RESOLUTION APPROVING THE PROPOSED IMPROVEMENT OF THE TUBIGON-CATIGBIAN VIA MACA-AS NATIONAL ROAD AND ENDORSING IT FOR INCLUSION IN THE GENERAL APPROPRIATIONS ACT (GAA) OF CY 2007 UNDER THE NATIONAL HIGHWAY FUND OR THE RURAL ROADS NETWORK DEVELOPMENT FUND (RRNDP)

WHEREAS, the Tubigon-Catigbian via Maca-as national road is a secondary national road with a total length of 40.666 km, with 17.088 km of which is concrete, 9.277 km of which is asphalt, and 14.217 km of which is gravel, which has long been in need of paving;

WHEREAS, the Tubigon-Catigbian via Maca-as road also includes in its stretch a dilapidated bridge, which requires upgrading and improvement to a standard 10-linear meter RCDG bridge;

WHEREAS, the Tubigon-Catigbian via Maca-as national road is an important route, serving as an alternate route connecting the municipalities of Cortes, Balilihan, Catigbian, Sagbayan and Tubigon;

WHEREAS, the improvement of this national road will not only improve farm-to-market access of the local farmers and growers in the surrounding community, but will spur faster economic growth around the area, thereby raising household incomes and contributing to the poverty reduction goals of the Province of Bohol;

WHEREAS, upon examination of this Body, the supporting Comprehensive Project Profile, MDC and SB Resolutions, and other supporting documents for this Proposed Project have been found meritorious and worthy of endorsement;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened -

To approve the Proposed Improvement of the Tubigon-Catigbian via Maca-as National Road and endorse it for inclusion in the General Appropriations Act (GAA) of CY 2007 under the National Highway Fund Or the Rural Roads Network Development Fund (RRNDP).

RESOLVED FURTHER, to endorse copies of this Resolution to the Honorable Sangguniang Panlalawigan for its information and support, and to the Regional Development Council of Region VII (RDC-VII) for its further support and endorsement.
