PDC-EXECOM RESOLUTION NO. 11-2006

A RESOLUTION STRONGLY REQUESTING THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCIAL GOVERNMENT OF BOHOL TO AUTHORIZE GOVERNOR ERICO B. AUMENTADO TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE PORTS AUTHORITY FOR THE IMMEDIATE IMPLEMENTATION OF THE PROPOSED CONCRETING OF THE 6.5-KM POBLACION UBAY-TAPAL PORT ROAD AT UBAY, BOHOL

WHEREAS, the Ubay-Tapal Port Road is a vital access road connecting the Port of Tapal to the economic and business centers of Ubay, whose current condition is so deteriorated that it has adversely affected the smooth, safe and efficient transfer of passengers and cargo to and from the port;

WHEREAS, the repair and improvement of this road would make possible the full utilization of the Port of Tapal as a major link in the Strong Republic Nautical Highway (SRNH) route;

WHEREAS, the Provincial Government of Bohol, with its limited financial resources, can only afford the rehabilitation and concreting of part of this 6.5-km stretch, and requires the assistance of the Philippine Ports Authority (PPA) to complete the concreting of the entire 6.5-km stretch;

WHEREAS, this assistance if extended by the PPA would greatly benefit the Provincial Government and its constituents, as well as the PPA

itself, since the concreting of the road would improve access to the Tapal Port Zone, thereby redounding to the benefit of all parties concerned;

WHEREAS, the Provincial Government of Bohol and the PPA are both willing to enter into a Memorandum of Agreement (MOA) setting forth their respective rights and obligations under this proposed arrangement, which would end with the turnover by the PPA of the project to the Provincial Government of Bohol once completed, with the latter being responsible for the regular maintenance and repair of the roadway thereafter;

WHEREAS, the Governor needs to secure the authorization of the Sangguniang Panlalawigan to affix his signature on the aforementioned MOA in behalf of the Provincial Government;

WHEREFORE, upon proper motion duly seconded, be it resolved by this Body in a meeting duly convened –

To strongly request the Sangguniang Panlalawigan of the Provincial Government of Bohol to authorize Governor Erico B. Aumentado to sign the Memorandum of Agreement with the Philippine Ports Authority for the Immediate Implementation of the Proposed Concreting of the 6.5-Km Poblacion Ubay-Tapal Port Road At Ubay, Bohol.

RESOLVED FURTHER, to endorse copies of this Resolution to the Honorable Sangguniang Panlalawigan for its approval.
